She also provided an update on the Seniors' Flu Shot Clinic and Health & Wellness Bag Grab n' Go as well as the additional dates for upcoming flu shot clinics being offered by the Town of Windsor Public Health Department.

Old Business:

Currently, there is no need to promote the COAPD as there was a very positive response to the article posted in the Windsor Journal and new members are being appointed. Right now, there are enough commissioners to continue to hold meetings. Liaison Joyce and Chairperson Roby have a meeting set up with Commissioner Gauthier and are working to schedule a meeting with Commissioner Copeland to provide orientation. This should be complete before our next meeting in November.

Follow up on Development/Scheduling/Presentation of:

"Depression/Anxiety/Isolation", "Fats not Fiction in COVID19, Make the most of your TELEHRALTH MD visit, Hand Hygiene: "Clean Hands Saves Lives", Flu Season: Immunization Facts/Clinic info

Chairperson Roby provided a brief background for Commissioner Copeland on the current project the COAPD has been working on. Ms. Roby explained that she connected with WIN TV, and recorded her voice reviewing important documents on the topics of "Facts not Fiction for COVID19", making the most of your telehealth visits, hand hygiene and flu season. WIN TV will post as a filler on their channel and will plan to run the recordings through January. Chairperson Roby will connect with WIN TV around the holidays to determine if the recording should run longer into the New Year.

Regarding the topic/presentation of "Depression/Anxiety/Isolation", Commissioner Brown reached out to Spectrum Psychotherapy Centers, LLC, located on Mechanic Street, Windsor. She connected with Dr. Penta, a psychologist, who mentioned that a social worker reach out to Commissioner Brown to discuss this topic further.

She also mentioned an article she found on healthguide.org regarding **Dealing with Depression During Coronavirus -** In the midst of the global COVID-19 pandemic, it's easy to feel overwhelmed by hopelessness and despair - these tips can help improve your mood and ease depression. She suggested sharing this article. This topic will be discussed further during the November meeting.
