Item #1.Call to Order - Chairman Rick Hazelton called the meeting to order at 1:00 pm.

Item #2. Remarks of the Chairman – Chairman Rick Hazelton recognizing George Roebelen as a voting member this afternoon in Commissioner Rusty Pecks' absence.

Item #4. Police Station Construction Additions & Renovations Project – 9911

Jim Russo stated that the crews working on this project are taking the necessary precautions needed during the Caronoavirus19 pandemic. The project is moving along on schedule.

Commissioner Gary Johnson inquired regarding the security cameras. Paul Goldberg mentioned there will be updated security cameras inside and out and will be monitored by the Department.

Whit stated that the Police Dept. is scheduled to move to Addison Rd. sometime in July.

Whit stated that they are waiting on the State of Ct paperwork. This project is on hold for now.

Item # 10. Clover St. Elementary Section E Partial Roof Replacement Project - 9508

Whit stated that the Contractor still has not finished his punch list as of yet.

Item #11. Poquonock Fire Station Roof Design Project – 9518

Whit stated he received 5 bids. Waiting for approval. This project isn't scheduled to begin until Fiscal year 2021.

Item #12. Wilson Fire Station HVAC Design Project - 9517

Motion: Commissioner Gary Johnson moves to approve payment on Invoice #I16990 dated March 30, 2020 to Salamone & Associates, P.C. for Professional Engineering services rendered at the Wilson Fire Station HVAC Design project in the amount of \$800.00. Seconded by Commissioner George Roebelen.

<u>Item #13. Sage Park Middle School Alternative Energy & HVAC Efficiency Upgrade</u> <u>Project</u> – 9519

Whit stated he did receive bids and that this project is scheduled to start in Fiscal year 2021. The construction documents are 90% finished from Salamone & Associates.

It punctured about a dozen holes in the roof, smashed the windows and damaged the CMU wall. It needs to repaired, to keep it water tight. He will keep the Commission updated on this situation.
