Public Communications

Paul Panos of 480 Brookfield Rd concerned that we do not have a definitive answer from with van Zelm report. We have a chill water system and Mr. Rosario was good to take me around so they should have been able to understand why they were not working. There may be a fix to the current units. They are proposing a new entirely system, but you need to watch this Are you going to add a lot of weight? Or are you going to have other penetrations? We would like give update to the Board of Education I think it would be a good to have van zelm and give an overview on what had been done.

Leonard Lockhart (Member of BOE) of 57 Columbia Rd concerned with the envelope of the building. There was (3) studies done and (one) was the actual envelope meaning the structure the ease of the windows and doors. We got a pretty good situation that try to put on the building right now, but the envelope of the building still produce some type of negative pressure on the system. I would like to see forward thinking on how are going to actually address this as we are going down to our 10 year plan with the Board of Education. At the same time we have to recognize that it has been documented there is a true issue with this building.

Per Marco Aglieco, we ae continuing with the design and mention spoke to them earlier and things are moving along. The plan is to pre-order the equipment this week. I spoke to the manufacturer's rep and they are finalizing the details getting them on the list as a vendor. We should have this released for this week. The time limit is about 16 weeks. Per Rick advice to make sure we reach out to vanZELM and relay to them the concerns of (2) board members and people involved with the school itself. It is very important to stay on top of this. Advise to get a commitment in 2 weeks from now.

I went through the old drawings to further investigate the footing drains and uncovered that the footings were part of the design in the new addition. I spoke to our engineering staff here to figure out how we can address that or validate whether It's working and we are working with Department of Public Works to do some investigation next week to dig up some of the footing drains and see if we can confirm they are there if not functioning to see if there is some kind of blockage. At this point I have not addressed Hoffman engineering to do anything further hopefully I'll have answers for next meeting.
