<u>Item #1 - Oliver Ellsworth School Humidity Mitigation Design – 9574 CIP FY2024</u>

Per Marco Aglieco, Facilities Manager, reached out to the engineer and ask him to put the final bid package together so it can go out for bid. It could be by the end of this week or next week.

Motion: Commissioner Jim Bennett makes a motion for Marco Aglieco, Facilities Manager, in giving permission to establish abatement testing at Oliver Ellsworth School and not to exceed \$9,600.00. Seconded by Deputy Chairman Gary Johnson.

Item #3 - Sage Park Middle School HVAC Ph. 2&3 - 9542 CIP FY2023

Per Jim Russo, gave an update on Phase 2, still waiting on close out and final completion of their punch list. They were not there yet, hoping it will be done by the end of the month. It's gonna drag into next month as for Phase 3 with Action Air we are still waiting some close outs from them. They had schedule training on Thursday and Friday. There is one ongoing issue with the boilers which are not getting refilled. He recommends no more payments until everything is basically done and approved.

<u>Item #4 - LP Wilson HVAC Replacements & Additions Ph. 1 Construction – 9551 CIP FY2023</u>

Per Jim Russo, gave an update on Phase 1 – This past week they were doing some balancing. They are working on their punch lists and I am going to have a meeting with their project manager on site early next week. I will be checking their punch list and then establish a re-inspection. I haven't seen any close out and I haven't been notified yet that the town building inspector has been on site.

Per Marco Aglieco, Facilities Manager, for Phase 2 it went out for bid and we received the bids last Thursday. We have (5) contractors in the walkthrough and received only one bid. So we decide to break in phases 2A and 2B. 2A will be office administrative areas, basement and flooring and 2B painting rooms and fixing ceiling tiles. Peter Souza mention that the challenge with the breakout the charter threshold for a special town meeting before it can go to the town for referendum is lower than the \$3,570,000 by roughly \$50,000 dollars. Does the commission feel comfortable with just one bid to compare?
