Subject: Setting Mill Rate for FY 2025

### Discussion/Analysis

The voters adopted the FY 2025 General Fund budget of \$143,315,840 on June 18, 2024. The adopted budget requires a tax rate of 30.32 mills for real estate, personal property and motor vehicles.

Tax increases on real estate are based on individual property assessments as determined by the Town Assessor's office per the October 1, 2023 revaluation and a two year phase-in of said revaluation.

Due to the timing of the second budget referendum mailing of tax bills will be delayed by one month. Tax bills for real estate, business personal property, and motor vehicles (on the 10/1/23 Grand List) are expected to be mailed on or just before July 26, with payment due by Thursday, August 1, or no later than Tuesday, September 3, to avoid interest charges. Any bills not paid in full by September 3 will incur a monthly interest fee of 1.5%. Please note that if payment is not received prior to or on September 3, the taxpayer is liable for 1.5% interest for August as well.

### Recommendations

If the Town Council is in agreement, the following motion is recommended for approval:

**“MOVE that the mill rate for the Fiscal Year 2025 beginning July 1, 2024 be set at 30.32 mills for real estate, personal property and motor vehicles, which reflects the October 2023 property revaluation with a two year phase-in and a total estimated net taxable grand list for FY 2025 of \$3,928,000,000.”**
