## 7. Management Report

Work order numbers are looking much better. Emergency issues are now getting done in half a day. Residents not using the maintenance / emergency line so they are not seen until regular office hours. May get larger fridge magnets to remind people. Cleaned out abandoned and previously permission-pending units. Vacancy rates going down. Won't fill Shad vacancies in preparation for the renovations. Reviewing list of residents without insurance. Lease renewal guideline summary distributed to commissioners. Delinquencies are mainly rent. Smoking by residents seems to be decreasing. Feedback on the new RSC programming is great.

Consultant applied for additional funds for Shad Run. Contract should be in a couple weeks. Scope of work for previous project for Millbrook was lacking and had to be reworked several times. Will try to make this two-phase project run more smoothly. Got \$2 million, asking for \$4.6 million.
