# 6. COMMUNICATIONS FROM COMMITTEE MEMBERS

Mr. Mack's interview was disrupted by Councilor Walker who began yelling at the Chair when she respectfully requested he follow the meeting agenda and proceed with questions for Mr. Mack. He became enraged and began shouting directly at the Chair. His statements were verbally aggressive, despite several reminders that he was out of order and by several requests by the Chair that he rejoin the meeting.

In the room was Councilor Dobler and Mr. Mack and the Chair, Lisa Bress. The door was closed, but there were a few applicants in the hallway right outside the room.

He made personal attacks on the integrity of the Personnel Committee meeting and the Chair, saying things to the Chair such as, "I don't have to listen to you. What are you going to do to me? You can't do anything to me." I'm not a union member. This isn't a union meeting." Then he rose out of his seat, faced the Chair and continued to shout at her despite the Chair's attempts to provide information or call him to order.

After a few more attempts to bring Councilor Walker back to the meeting or to order, the Chair asked him to join or leave the meeting so we could continue and give Mr. Mack the interview he deserved. Councilor Walker walked away from the Chair and continued shouting to Mr. Mack, "You shouldn't even be interviewed. She doesn't want any black people on the committee". "She's being sued".

Then he turned back to the Chair and continued to shout angrily, "You're being sued. You shouldn't even be Chair of this committee." He turned to Mr. Mack again and said "I'm voting for you. You have my number. Call me." and left the meeting.

The meeting continued and the remaining Committee members were able to interview the rest of the candidates, but were behind schedule due to the interruption and applicants had to wait. Councilor Walker chose to leave the meeting so he was not present to vote on the motions. After he left, the Chair apologized to the public in attendance.
