Windsor Conservation Commission November 27, 2018

The meeting was called to order at 7:10 p.m.

The minutes from October 30th were amended by T. Hazel to read *Great Pond* where it appeared as *Grey Pond* (under the heading INPUT). A motion was made by N. Sachdev and seconded by L. Chayes to accept the amended minutes. Voted on and approved 6-0-0.

Chair Ann congratulated the chairs of the Nov 14th "Plastics" forum.

Discussion ensued on how to improve advertising future programs.

Ann, Nigel and Tom attended the CACIWC Conference and reported on several of the highlights.

Chair Ann talked about the seminar on climate change - attributed to both natural and manmade activities causing flooding, rising temperatures, fires and arctic shrinking, among other things. The push is to save more open space and wetlands which are considered the "lungs of the earth". She emphasized that only 7% of young people were actively involved in the environment.

Ann also mentioned that the National Land Trust Council is proposing a bill that would compel the buyer of a property valued in excess of \$150,000 to pay an additional 1% of the purchase price. The 1% revenue would be placed in a dedicated fund. This would qualify towns for grants, in an attempt to maintain their character. This evidently has worked in other states. Ann gave an example in Warwick, New York where over 3,000 acres were saved. Also, it is felt that the state is over developed and towns should be encouraged to recycle existing vacant buildings rather than engage in new construction.

There was also a live DRONE demonstration.

Nigel talked about the apps available for virtual tracking and reporting.
