

IMPORTANT ANNOUNCEMENT REGARDING AARP TAX-AIDE PROGRAM -INCOME TAX ASSISTANCE SERVICE

The Windsor Senior Center, located at 599 Matianuck Avenue, has been notified that the AARP Tax-Aide Program will not be providing income tax filing assistance at the LP Wilson Community Center this year. This is due to a variety of reasons including a shortage of AARP Tax-Aide volunteers in our area to perform this service.

Below are some resources that may be helpful in filing your 2020 Income Taxes:

The Volunteer Income Tax Assistance (VITA) - They can be reached at 800.906.9887or use the VITA Locator Tool to find a VITA site near you. VITA sites offer free tax services from mid-January through mid-April to individuals who qualify. BASIC ELIGIBILITY FOR VITA: The VITA program is for households who generally make \$57,000 or less, persons with disabilities and limited English speaking taxpayers who need assistance in preparing their own tax returns.
